46) <u>Rick Engle</u>

48) Dog Licenses

The Town Board pushed the Dog License Resolution for the last few months to do more research on what the surrounding towns charge for the same criteria. After further investigation Acting Supervisor Joe Denis found our prices to be within reason of other towns with our same population and proposed that no changes should be made to the current local dog fees.

All dog licenses expire on August 31, 2022 and must be renewed within 30 days, fees payable as described below:
