Annual Drinking Water Quality Report for 2022 Conifer Water System Main Street, Conifer (Public Water Supply ID # 4417731)

INTRODUCTION

To comply with State regulations, the Conifer Water System will be annually issuing a report describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect our drinking water sources. This report provides an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards. Regular maintenance and monitoring that was done throughout the year. There were no violations.

WHERE DOES OUR WATER COME FROM?

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include: microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the number of certain contaminants in water provided by public water systems. The State Health Departments and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Our water system serves approximately 80 people through 32 service connections. Our water source is a series of drilled wells which are located on Main St., Conifer. In June/July of this year, the Highway Department replaced a well pump that had died. The Town of Piercefield hired Ken Stoll to run about 600 ft of new wire from the pump to the Conifer pump house. They also replaced 8 well caps at this time. The water is treated with chlorine prior to distribution. Our system is historically at very low risk of contaminants, as witness the adjoining table.

ARE THERE CONTAMINANTS IN OUR DRINKING WATER?

As the State regulations require, we routinely test your drinking water for numerous contaminants. These contaminants include: total Coliform (monthly), Sodium, Iron, Gross Beta, Gross Alpha, Barium, Fluoride, Sulfate, Chloride, Zinc, Nitrite, Nitrate, HAA5, TTHM, Lead, Copper, and POCs/Vinyl Chloride. The table presented on the last page depicts which compounds were detected in your drinking water. The State allows us to test for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year old. None of the compounds we analyzed for were detected at unacceptable levels in your drinking water.

It should be noted that all drinking water, including bottled drinking water, may be reasonably expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. WHAT DOES THIS INFORMATION MEAN?

As you can see by the table, our system had no violations. We have learned through our testing that some contaminants have been detected; however, these contaminants were detected below New York State requirements.

We are required to present the following information on lead in drinking water:

If present, elevated levels of lead can cause serious health problems, especially for pregnant women, infants, and young children. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. The Conifer Water System is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline (800-426-4791) or at http://www.epa.gov/safewater/lead.

We are required to present the following information on nitrate in drinking water:

"Nitrate in drinking water at levels above 10 mg/l is a health risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant, you should ask for advice from your health care provider."

IS OUR WATER SYSTEM MEETING OTHER RULES THAT GOVERN OPERATIONS?

Last year, our system was in compliance with applicable State drinking water operating, monitoring and reporting requirements.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards.

DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Some people may be more vulnerable to disease causing microorganisms or pathogens in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice from their health care provider about their drinking water. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium, Giardia and other microbial pathogens are available from the Safe Drinking Water Hotline (800-426-4791).

WHY SAVE WATER AND HOW TO AVOID WASTING IT?

Although our system has an adequate amount of water to meet present and future demands, there are a number of reasons why it is important to conserve water:

- Saving water saves energy and some of the costs associated with both of these necessities of life
- Saving water reduces the cost of energy required to pump water and the need to construct costly new wells, pumping systems and water towers
- Saving water lessens the strain on the water system during a dry spell or drought, helping to avoid severe water use restrictions so that essential fire-fighting needs are met.

You can play a role in conserving water by becoming conscious of the amount of water your household is using, and by looking for ways to use less whenever you can. It is not hard to conserve water. Conservation tips include:

- Automatic dishwashers may use up to 15 gallons for every cycle, regardless of how many dishes are loaded. So, get a run for your money and load it to capacity
- Turn off the tap when brushing your teeth
- Check every faucet in your home for leaks. Just a slow drip can waste 15 to 20 gallons a day. Fix it and you can save almost 6,000 gallons per year
- Check your toilets for leaks by putting a few drops of food coloring in the tank, watch for a few minutes to see if the color shows up in the bowl. It is not uncommon to lose up to 100 gallons a day from one of these otherwise invisible toilet leaks. Fix it and you save more than 30,000 gallons a year.

CLOSING

The Town of Piercefield is dedicated to the task of providing you with a consistent supply of high-quality drinking water. This requires continuous monitoring and maintenance of our water pumping stations in addition to frequent sampling for contaminants. Last year, the cost of Conifer pump station utilities (propane, electricity, phone), water test fees, labor, and materials and hardware to keep the pumps functioning properly totaled \$19,760.10. This does not include the water district debt service, which is included in your Town property tax levy.

Thank you for allowing us, as we continue to provide your family with quality drinking water this year. In order to maintain a safe and dependable water supply we sometimes need to make improvements and repairs that will benefit all of our customers. The costs of these activities may be addressed through rate adjustments. We ask that all our customers help us protect our water sources, which are the heart of our community. HAA5: Some people who drink water containing halo acetic acids in excess of MCL over many years may have an increased risk of getting cancer.

Nitrate: Infants below the age of six months who drink water containing nitrate in excess of the MCL could become seriously ill and, if untreated, may die. Symptoms include shortness of breath and blue-baby syndrome.

Copper: Is an essential nutrient, but some people who drink water containing copper in excess of the action level over a relatively short amount of time could experience gastrointestinal distress. Some people who drink water containing copper in excess of the action level over many years could suffer liver or kidney damage. People with Wilson's Disease should consult their personal doctor.

DEFINITIONS:

Milligrams per liter (mg/l) - One part per million: corresponds to one minute in two years or a single penny in \$10,000.

Micrograms per liter $(\mu g/l)$ - corresponds to one part of liquid in one billion parts of liquid (parts per billion -ppb).

Maximum Contaminant Level (MCL) - The "Maximum Allowed" is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) - The "Goal" is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or

expected risk of health. MRDLGs do not reflect the benefits of the using of disinfectants to control microbial contamination.

Dioxane (ug/l): Laboratory studies show that 1,4-dioxide caused liver cancer in animals exposed at high levels throughout their lifetime. Whether 1,4- dioxane causes cancer is unknown. The United States Environmental Protection Agency considers 1,4-dioxane is likely to be carcinogenic to humans based upon studies of animals exposed to high levels of this chemical over their lifetime.

Action Level (AL) the concentration of a contaminant that, if exceeded, requires treatment or other requirements which a water system must follow.
