46) Marlene Ashton

In the past month, Marlene reached out to Elise Stefanik's office and spoke with Allen, a staff member there. She informed Allen about the difficulties the Town of Piercefield is experiencing due to the lack of home healthcare services from St. Lawrence County. Marlene emphasized to Allen that "she is not looking for a quick fix.". Allen expressed his belief that the County is unlikely to provide assistance, suggesting that the Town would need to pursue State or Federal funding for support. Additionally, Marlene mentioned that she has approached the local newspaper and initiated a petition. Allen recommended that she expand her advocacy efforts by sending letters to Washington, D.C., to ensure her concerns are heard at the state level. Councilmember Carol Dimond informed Marlene that she had contacted District Legislator Rick Perkins at Marlene's request. Mr. Perkins concurred with Allen that the likelihood of the Town receiving home health aide services from St. Lawrence County is low, noting that he hasn't seen a County Nurse in 15 years. He also indicated to Carol that he would make an effort to attend the board meeting scheduled for April 17th.

47) Highway Report

Highway Superintendent Jay Rust presented Assembly Bill A. 5890. This bill seeks to amend the state finance law, the general municipal law, and the highway law to expand the New York State Buy American Salt Act to include rock salt or sodium chloride mined or hand harvested in Canada. Jay is asking the board to adopt a resolution endorsing this bill.

Highway Superintendent Jay Rust has requested the following purchase approvals.

- Battery operated jack hammer in the amount of \$2,200.00 to be split between the highway department and water departments.
- Calcium for gravel roads in the amount of \$5,183.20

Supervisor Joe Denis would like to look into different outlets for pricing on the heaters for the youth center. The approval to purchase heaters has been tabled until alternative pricing options are reviewed.

Jay reported a sub main water break at 5 Dewey Ave. The line, which was installed in 1994, had rotted. The crew fixed the break and replaced the damaged section with stainless steel and brass. The crew installed the new ceiling in the youth center and will begin painting this week. A 4ft broom attachment for the mini excavator was purchased for sweeping sand. This purchase will be covered by CHIPS. Jay has also been looking for a mower attachment for the mini to cut back trees. If the attachment is purchased this will also be covered by CHIPS. Jay also reported purchasing and installing 2 new LED lights for outside the garage and town offices.

Councilmember Gina Sarazen raised concerns regarding the excavator costs for the month. Jay explained that a mechanic from Tracy was required to connect to the motor, and that the injectors, wiring for the injectors, and the valve cover gasket all needed replacement. He also mentioned that the town will be receiving a bill from Mitchells due to the thumb on the excavator not functioning properly and failing to hold. The guys replaced the piston and cleaned the valves, yet the issue persists.

SUPPORTING ASSEMBLY BILL A.5890, "AN ACT TO AMEND THE STATE FINANCE LAW, THE GENERAL MUNICIPAL LAW, THE PUBLIC AUTHORITIES LAW AND THE HIGHWAY LAW, IN RELATION TO AWARDING CONTRACTS FOR THE PURCHASE OF ROCK SALT OR SODIUM CHLORIDE MINED OR HAND HARVESTED IN CANADA"

WHEREAS, Assembly Bill A. 5890, seeks to amend the state finance law, the general municipal law, the public authorities law, and the highway law to expand the New York State Buy American Salt Act to include rock salt or sodium chloride mined or hand harvested in Canada; and

WHEREAS, the proposed amendment will allow state and local agencies to award contracts for rock salt or sodium chloride to bidders offering products mined or hand harvested in either the United States or Canada, provided their offer is within ten percent of the lowest price or best value offer; and

WHEREAS, the bill includes provisions to prevent misrepresentation of the origin of rock salt or sodium chloride, ensuring that products labeled as "Made in America" or "Made in Canada" are genuinely sourced from those countries, with penalties for intentional mislabeling; and

WHEREAS, the legislation maintains consistency with the state's obligations under applicable international agreements related to government procurement; and

WHEREAS, the inclusion of Canadian-sourced rock salt and sodium chloride will provide greater flexibility and potentially lower costs for state and local agencies in procuring these essential materials for winter road maintenance;

WHEREAS, expanding the sourcing options to include Canada, a close economic partner and neighbor, strengthens regional supply chains and ensures a more reliable supply of rock salt and sodium chloride; and

WHEREAS, this amendment supports both domestic and North American production, promotes fair competition, and enhances the ability of New York State agencies to effectively manage winter road conditions; and

WHEREAS, the legislation addresses the potential for fraudulent labeling and ensures that the integrity of the procurement process is maintained.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Piercefield hereby expresses its strong support for Assembly Bill A. 5890, which amends the New York State Buy American Salt Act to include rock salt or sodium chloride mined or hand harvested in Canada; and
