## 114) Highway Report

Highway Superintendent Jay Rust reports that the crew has been working on the Mt Arab Road hauling in material and removing sections of road in preparation for blacktop. Jay presented the board with 2 updated quotes from Tracey Road Equipment for a loader. The loader that was \$199,191.00 in January is now \$213,730.69. Jay got a quote for a similar loader that is \$209,802.76. Tracey Road offers municipalities to finance through them for a term of 5 years. Supervisor Denis spoke with Bill Dashnaw and Jarrod Radley, both confirming that CHIPS will not reimburse for equipment that has an outstanding loan, it must be paid for in full before getting reimbursement. Jay emphasized his frustrations regarding the \$256,000.00 available in CHIPS funds that cannot be utilized, as the highway budget does not permit the Highway Superintendent to expend these funds and receive reimbursement prior to the due date of bills, payroll, insurance, and other expenses.

## 115) Code Enforcement Officer Report

Code Officer Nicholas Snyder submitted his monthly report for June.

## 116) Loren Bailey

Loren Bailey, a resident of Mt Arab Road, expressed gratitude to the Highway Department for their work on the Mt Arab Road. Loren inquired with Jay about any plans for blacktopping this year. Jay mentioned that there are plans for blacktopping, but the schedule is contingent on when the county can send a crew to help. Loren also highlighted the resident's appreciation for the mowing, which has been effective in reducing the wild parsnip.

# 117) Alysa Hopkins

Alysa inquired whether the board has reached a conclusion regarding the opening of the youth center. As of now, no decision has been finalized; however, if the center does open, it will not occur until the end of September. Councilmember Gina Sarazen feels that a handful of children causing problems should not spoil the opportunity for every child in the community. Gina suggested starting with the center open 2 days a week instead of 3. Kevin Willette asked if a decision has been made about reinstalling the playground. Supervisor Denis confirmed that the idea has not been discussed at this time.

## 118) Carol Dimond

Councilmember Dimond shared the major project public notice from the APA regarding the installation of a new cell tower by Verizon Wireless near Setting Pole Dam Road. #### 119) Marlene Ashton

Marlene presented the board with a letter she has written along with a letter from resident Patty Reandeau that will be read in front of the Board of Legislatures during the citizen participation segment of their monthly meeting on August 4<sup>th</sup>. Marlene has drafted a new petition. She would also like everyone to be aware that the Seniorama (a health and information fair for older adults and their families) is being held on July 28<sup>th</sup> from 10am-2pm at the Akwesasne Mohaw Casino.

## 120) Dan Dewyea

Dan requested that the Town Board consider reopening the Piercefield Beach as a recreational site. According to his research, with the correct signage, deeming the old beach a recreational site is possible under a "use at your own risk" policy. Dan emphasized that the town has put a lot of money into the beach and it is discouraging to see it fall into disuse. Looking at a broader picture, the lack of accessible local outdoor spaces for youth and families leave little incentive to keep residents and visitors engaged. Town Supervisor Joe Denis will consult with the insurance company to see if the old beach can be labeled a recreational area with own risk access.

## 121) Conifer Water Break Bill

The bill sent to the homeowner for the water main break in Conifer in January of 2024 remains unpaid. Kirk has sent multiple notices that have gone unanswered. A discussion was had on whether the money owed could be relevied onto the homeowner's property tax bill. Town Supervisor Denis will follow up on how to proceed with the Town Attorney.

# 124) Chickens on the loose

Councilmember Gina Sarazen informed the board that a property owner has chickens roaming throughout the town, encroaching on other homeowners' properties. Homeowners have expressed their concerns to her, stating they are hesitant to let their own animals outside for fear that they might chase the chickens. She is concerned about the potential for injury to anyone's pets. Councilmember Angela Rust suggests that the property owners in the area should discuss the matter with the chicken owner before the Town takes any action.

#### 125) Livestock

Councilmembers Gina Sarazen and Carol Dimond inquired whether the Town has a Local Law pertaining to livesock. Councilmembers are concerned that waste from the cows is contaminating the water that leads down to the river. The Town Clerk will research any relevant Local Laws on this issue. Supervisor Denis will contact CEO Nicholas Snyder to investigate the situation.
